### Introduction:

## The role

MSI seeks a Head of Programmes in their Global Programmes and Philanthropy (GPP) department to oversee a range of anticipated large grants funded by the Children's Investment Fund Foundation (other foundation donors will potentially also be added to the portfolio). The Head of Challenge Fund – CIFF Programmes is responsible for the high-quality stewardship of newly approved and anticipated global and bilateral CIFF investments totalling over \$70m to advance sexual and reproductive health services and increase modern contraceptive prevalence in six countries across West and Central Africa.

The Head of will oversee a team of three staff and be responsible for supporting an upcoming \$70 million portfolio to be implemented in six West and Central African countries. Reporting to the Associate Director, the Head of will oversee the internal start-up and delivery of the programmes and followed by the support to country programme and partners' implementation, ensuring delivery of agreed deliverables (including payment by results KPIs). In addition, the Head will work across departments at MSI to ensure learnings across the organisation and the country programmes, reflecting the technical leadership of this exciting portfolio. Alongside the Associate Director, the Head will play a critical role in donor relationship management including complex cross-cutting reporting and co-funding management. This is an exciting senior role that requires management, leadership and strong communication and facilitation skills,

analytical and problem-solving skills, excellent ability to work across teams to deliver results, and great attention to detail.

This role and project team is part of the broader team supporting CIFF investments. The team oversees the technical design and execution of strategic large scale foundations investments and is responsible for safeguarding and advancing MSI's relationship with CIFF as a key contributor to achieving MSI's mission. The team provides organizational leadership to ensure that MSI's strategy, policy, systems, and capacities are responsive to donor priorities and investments.

## Key Responsibilities

### Stewardship of a portfolio of large-scale foundations and grant management relationships

- Accountable for portfolio start-up and development of key guidance for sound implementation across the country programmes and across the team of managers and advisers.
- Accountable for stewardship and implementational performance of all projects and grants within the role's donor portfolio ensuring all KPIs delivered on time and to budget and that all risks and issues are reported timely and accurately internally and to donors when necessary.
- Accountable for ensuring donors and MSI standards for delivery, reporting and compliance are met and exceeded through: cohesive, accurate and high quality financial and narrative reporting; ensuring with country programmes and regional teams that implementation approaches are in line with donor expectations and will achieve the results required to deliver payment KPIs and to achieve logframe or other project monitoring results; ensuring corrective action is implemented where necessary
- Ensure any changes to projects and agreement minimise risk to MSI and support implementation of MSI's 2030 strategy.
- Build country programme capacity to effectively manage CIFF funding and engage with CIFF as a donor
- Work closely with MSI regional teams and country programmes to navigate complex donor discussions around project progress, challenges experienced, contractual changes, value for money and future investments.
- Ensure coherence across donor communications on key programme management issues, developing and rolling out guidance across MSI where appropriate.
- Drive initiatives which facilitate knowledge sharing on the requirements of strategic foundations and best practice ways of working so country programmes remain up to date on donor requirements, to strengthen their own performance and enhance MSI's reputation for quality programme delivery.
- Work closely with the Associate Director, responsible for donor relationships, to ensure donor grant relationships grow in a manner that positions MSI as the partner of choice, feeds into donor specific strategies, advances opportunities to fund the mission and shapes the sector

### Team leadership

- Provision of high-quality line management to a team of two managers and one adviser delivering grant management to specific parts of the portfolio, global and bilateral.
- Ensure direct reports are motivated, receive regular 1-2-1s, development opportunities, and coaching and mentoring as required to support their professional development.

• Be a visible lead within the broader GPP department, working other senior colleagues to create a resilient, adaptable team who feel supported, connected and equipped to deliver MSI2030 goals.

#### **Technical Coordination and Leadership**

- Manage the effective delivery of dedicated technical or operational areas for the portfolio, especially the learning agenda and associated dissemination strategy.
- Together with the Evidence & Impact team, support data collection and documenting best practice, lessons learned and innovations for specific outputs or technical/thematic areas (to be identified); contributing to or co-ordinating Technical Working Groups;

- Skilled in identifying, managing and escalating risk at project, donor and departmental level
- Experienced in building and managing strong, remote grant management relationships with internal and external stakeholders
- Experience managing compliance, performance and risk of sub-partners
- Skilled at communicating about complex and sometimes highly sensitive grant management issues with donors and other external stakeholders
- Excellent skills in communicating evidence, excellent facilitation skills with proven ability to synthesize complex technical component into easy-to-understand briefs or presentation.
- Experience and knowledge of global health or allied thematic area (desirable)
- Knowledge of the French language (written and oral) is preferable for this role.
